# 2007 WRPA Award Winners

## President's Award: William M. Overby

Administration of Justice Program Chair and Parks Law Enforcement Academy Commander, Skagit Valley College, Mount Vernon, Washington

Beginning in late December and running through March, the Skagit Valley College Parks Law Enforcement Academy annually provides students with more than 700 hours of quality reinforced instruction by top professionals conducted in both academic and field environments. Strict rules of conduct and decorum are enforced. Excellence in academics and all practicums is expected, and confidence-building and teamwork are emphasized.

#### **About the Program**

The Skagit Valley College Parks Law Enforcement Academy is approved by the National Park Service (NPS) as a seasonal law-enforcement training program. It meets state, county and city parks requirements for law enforcement commissioning and also satisfies requirements for many police agencies. Graduates of this program receive 30 quarter credits and a certificate of program completion, provisional completion documentation and/or modular certification.

Graduates of the Parks Law Enforcement Academy gain a competitive edge in seeking jobs with the various agencies in the law-enforcement community. Graduates have been highly successful in securing employment with the National Park Service; Washington State Parks; the U.S. Fish and Wildlife Service; Everett City Parks; the Washington State Reserve Officer program; and many other federal, state, county and city organizations. First established in 1991, the program has flourished during the past 10 years, with more than 300 cadets

participating. Since 2002, William M. Overby has served as the Administration of Justice chair at Skagit Valley College and commander of the Parks Law Enforcement Academy.

Bill has been a WRPA member since 1970 (while enjoying his time as a Cougar and earning his parks and recreation degree at Washington State University), and he has committed his life's work to park resource management. Beginning as an entry-level park ranger in June 1969, he was recognized for his burgeoning potential and promoted through eight full-time commissioned park ranger levels while managing diverse sites in rural, suburban and urban areas in Washington state.

Until his recent retirement from Washington State Parks, Bill was responsible for the operations, management, budget and critical decision-making for Deception Pass State Park (Whidbey and Fidalgo Islands) for the past 20 years. Deception Pass State Park is a 4,134-acre marine and camping park with 77,000 feet of saltwater shoreline and 33,900 feet of freshwater shoreline on three lakes. Rugged cliffs drop to meet the turbulent waters of Deception Pass. The park is outstanding for breathtaking views, old-growth forests and abundant wildlife.

One of the most visited state parks, Deception Pass required a demanding set of people and incident response skills. Bill had them in spades! A graduate of the National Fire Academy's Unified Incident Command School, Bill also served as a firefighter, EMT, lieutenant, assistant chief and chief of Snohomish County Fire District #20 during a six-year period. He has served as a lead instructor, subject-matter expert and consultant on a number of committees and task forces. Since 1984, he has served on the Island County EMS and Trauma Council, providing pre-hospital emergency medical response planning and support to more than 100,000 citizens and visitors.

Throughout his 31 years of distinguished service to Washington State Parks and his mentoring of future park rangers, Bill has epitomized the words "integrity," "commitment" and "professionalism." What images or words do you associate when you imagine the ideal park ranger? "Courageous," "approachable," "caring," "calm," "protective," "steward" and "knowledgeable" likely are just a few. Bill Overby embodies those words and more and now serves to mentor future park rangers who are dedicating their lives to the protection of valuable cultural, historic and environmentally sensitive park lands.

For his commitment and dedication to the parks and recreation field, it is my pleasure to bestow the 2007 WRPA President's Award to William M. Overby, chair of Skagit Valley College's Administration of Justice Program and commander of its Parks Law Enforcement Academy. Please join me in congratulating Bill for his honored service.
